**Sub: Restructuring of Land Management Wing of DDA.**

In order to sync the organizational structure of Land Management Wing of DDA with the Revenue Department of GNCTD (as per link [http://revenue.delhi.gov.in/wps/wcm/connect/doit\\_revenue/Revenue/Home/Organization+Setup/List+of+villages%2811+District+Wise%29](http://revenue.delhi.gov.in/wps/wcm/connect/doit_revenue/Revenue/Home/Organization+Setup/List+of+villages%2811+District+Wise%29)), following changes in current structure of Land management Department of DDA is ordered with immediate effect. - (1) Henceforth, there will be 11 Zones corresponding to 11 Districts of National Capital Territory of Delhi and a Co-ordination branch headed by Dy. Directors. Each Zone/District is further divided into 3 divisions (33 divisions in total) corresponding with the sub-divisions of National Capital Territory of Delhi.


